- Community Manager Dave Hering forwarded a letter to Henrico County Police expressing the community's concerns over vehicles speeding into the community. Sherwin Place was pointed out as a particular item of concern since it is one of the main entrances to the community.
- Dave Hering will contact Swim Metro to obtain a contract proposal for the 2008 pool season so that the board can consider the contract at the next board meeting.
- A motion was made and approved by the board as to the installation of a storage shed at the pool with the inclusion of certain recommendations made by Design Management Associations (DMA). The siding and roof shingles will match what is currently on the pool house.
- There will be a follow up to identify if there are any costs associated with the new optional ACH payment option for homeowners to use in paying their quarterly dues.
- It was indicated that our upcoming budget for 2008 should consider funds for power washing certain street signs and post and other fence posting. This item will be considered when approving the new fiscal year 2008 budget.

We meet the second Thursday of every month. Residents are strongly encouraged to attend. These meetings are a great place to get up to date on the happenings in the neighborhood and a forum to express any concerns, questions, or compliments.
