NOTES FROM THE LAST HOA MEETING... ... September 13th, 2007

Reminder Residents: Real Estate Signs are only allowed in the common areas during the weekend. Please remove your signs on Sunday evening!

- Dennis Weiss asked Dave Hering to have the swing set at Holliman playground checked out. One of the posts may be rotten and there should be an inspection. He recommended using a V-support rather than a single post. The President also noted that the canvasses have been replaced at the playground.
- Dick Toskes said that the financials appear to be in order. He asked Dave Hering to check on the expenses to the Printing and Reproduction accounts as for the past two months, these have seemed high. There is more than \$166,000 in the Reserves account and past due assessments have gone down.
 - o In reviewing the budget, he noted some "unplanned" expenses: legal costs, back payment of some fees to DMA, picking up full costs of DMA fees, pool furniture for two years, and some paving which may be transferred as a Reserves account expense. He suggested that in order to get expenses in line with the budget, contributions to Reserves be suspended for the remainder of the fiscal year and resumed April 1, 2008 after determining what is needed to maintain an appropriate balance in Reserves.
- Dick Toskes said the 2006-2007 tax return has been prepared and needs to be signed by the President
- Motion was made and unanimously approved to suspend contributions to Reserves beginning October 1, 2007 until the beginning of the next fiscal year, April 1, 2008.
- There was discussion of need for and use of storage at the pool house. Dick Toskes said there is a space about 12 feet by 5 feet (where there had been a drink machine) where doors could be installed and the grill and other supplies could be stored out of the way of pool supplies and pool furniture. Becky Davis added that it is a good time to think about all storage needs and consider an add-on to the pool house. It was noted that some supplies are being kept at home and could be more properly stored in bins at the pool house. Dennis Weiss suggested that the doors should

be installed at the recessed space first and then see if more space is needed. The board asked Dave Hering to get a proposal for installing doors.

- Dave Hering reported that the tarps have been replaced at the Holliman playground.
- Bernard Cordeau has repaired and installed a replacement part to the playground equipment at Holliman and the board thanked him for his help.
- A Motion was made and unanimously approved authorizing replacement of anchors for the pool cover by Swim Metro at a cost of about \$567.00. This is based on an estimate made by Swim Metro last year.

We meet the second Thursday of every month. A location for next month's meeting will be sent in a separate notice. Residents are strongly encouraged to attend. These meetings are a great place to get up to date on the happenings in the neighborhood and a forum to express any concerns, questions, or compliments. All meetings follow Roberts Rules of Order.
