NOTES FROM THE LAST HOA MEETING... ... October 9th, 2008

- Treasurer D. Toskes provided the board with an update on the financial status of the association which continues to be in very good shape. Delinquent accounts were substantially reduced in September and are currently below last year's level. Dick also advised that the federal and state income tax returns have been filed and we are currently awaiting the final audit report from our outside accountants.
- Secretary J. Nyman agreed to contact our Web site manager Denton to update our site to include minutes from all of the 2008 board of directors' meetings. Also, the web site will be updated to make reference to our management company on the home page so that homeowners are aware of how to obtain settlement (sale of residence) packages for closing.
- Homeowner Mr. Barnhill attended the board meeting to express his concerns over the lack of welcome committee activities and he suggested several recommendations on how to improve communications within the community. The board expressed their willingness to have Mr. Barnhill join the welcome committee which he agreed to and also for Mr. Barnhill to attend future monthly board meetings so that his services could be utilized.
- M. Strother was introduced as the new welcome committee chairperson and the board briefly discussed future welcome committee activities.
- Director B. Cordeau advised the board that all of the street sign post and entrance signs have now been painted.
- President E. Wilder advised the board that Attack's lawyer will attend the next board meeting to explain their request regarding the requested easement. In the mean time, we are awaiting a review of the pertinent legal documents by our attorney regarding this matter.

 The board also approved the selection of Tilley's Landscaping for their grass cutting and maintenance services; \$39,538 for the 2009 and \$40,329 for the 2010 season (with a minor adjustment to the contract proposal)

We meet the second Thursday of every month. Residents are strongly encouraged to attend. These meetings are a great place to get up to date on the happenings in the neighborhood and a forum to express any concerns, questions, or compliments. All meetings follow Roberts Rules of Order.
