NOTES FROM THE LAST HOA MEETING... ... September 10th, 2009

- Treasurer, D. Toskes reported that the financial condition of the association remains good. Our delinquency accounts (dues in arrears) are currently in line with the levels of prior years. For the month of August, major expenditures included payments for our pool management (\$9796), grounds maintenance (\$3206), management fees (\$3100), and \$3124 for water irrigation system.
- Treasurer, D. Toskes also signed off on the filing of our Federal and Virginia income tax returns which were prepared by our outside accounting firm, Adams, Jenkins and Cheatham PC.
- Pool Chairperson C. Bender indicated that overall we have had a very successful pool season. She took an inventory of all pool furniture which was submitted to the board, and it appears that we will need to purchase several umbrellas for next year's pool season. D. Toskes and B. Cordeau assisted the lifeguards by power washing all of the pool furniture prior to its year end storage. We appreciate their efforts.
- The board authorized a community "yard sale" event to be held in mid-October. Advertisements will be placed in local newspapers prior to the event. Residents are encouraged to participate in this community event. The board approved the purchase of two "yard sale" signs to be used for this year's event.
- D. Toskes informed the board that "Welcome" packages are now being distributed to new community residents and the reaction residents receiving the welcome package has been very positive.
- Director, B. Cordeau installed our new "no trespassing" and "playground sign" as requested by the Neighborhood Watch Committee.
- Director, B. Cordeau completed all repairs (replaced all rotten boards and facing) to the pavilion.
- The board discussed at length the complaints of our residents concerning dog waste not being picked up by the dog owners; the board will continue to issue reminder emails to our residents that they must take appropriate paper towels or bags to pick up after their dogs when walking them throughout the community.
- The board approved the removal of two trees that were representing a danger to the community; agent D. Hering will contact our tree company for immediate action.

- D. Hering indicated that he will update our collection policy statement and present it to the board at the next meeting.
- The board also discussed a complaint that was received about a group home within the community; however, additional facts and clarification that have been received, eliminates the need for any further action.

We meet the second Thursday of every month. Residents are strongly encouraged to attend. These meetings are a great place to get up to date on the happenings in the neighborhood and a forum to express any concerns, questions, or compliments. All meetings follow Roberts Rules of Order.
