## NOTES FROM THE LAST HOA MEETING... ... April 8<sup>th</sup>, 2010

- President Eric Wilder welcomed new director Morris Leake to the Board.
- Treasurer, D. Toskes reported that the financial condition of the association continues to be
  excellent and that the association ended its fiscal year substantially under budget. Our
  delinquency accounts (dues in arrears) decreased from last month and the arrears are in line
  with previous years. For the month of March, major expenditures included payments for
  Management services (\$3100), Lawn Service (\$3200), Insurance (\$1732) and Web Site
  Development (1193).
- Treasurer, D. further indicated that he will be purchasing a new CD from Union First Market with the funds from a maturing CD from BB&T since Union First Market is offering higher rates. Subsequent to the meeting, a new CD was purchased from Union First Market in the amount of \$59, 499 for a 15 month period of time.
- Managing Agent, D. Hering indicated that Tilley's sprayed all of the common grounds for weeds and have tested the irrigation system. The irrigation system has been turned on due to the application of spring fertilizers and other actions by Tilley's.
- Our new pool management company will be attending the next board meeting to go
  operations for the upcoming year. Repairs have been made to the pump motor during the
  past month.
- All Residents should have received a letter in the mail concerning our 2010 Pool Registration process; our pool will open on May 29, 2010. Residents should either mail back their pool registration Form or go on line at <a href="https://www.magnoliaridge.org">www.magnoliaridge.org</a> to register in order to obtain their pool passes.
- PLEASE BE AWARE THAT POOL PASSES WILL NOT BE ISSUED IF A RESIDENT IS BEHIND IN THEIR ASSOCIATION DUES.
- During the month, the board received an updated manual for the maintenance of our community web site; changes were made to the web site in accordance with previous discussion with Denton.
- The board discussed making some minor improvements to the playground area near Holliman (walking area plus re-mulching of the key areas). Managing Agent, D. Hering will set up a meeting with Tilley's to review their recommendations.

- The following officers were elected: E. Wilder President, B. Davis Vice President, D. Toskes Treasurer, B. Cordeau Secretary and M. Leake Director at Large.
- <u>Pool Policy for rental homes</u>: The Board discussed at length the policy for issuance of pool passes to renters; it was decided:

One set of pool passes per home, either the owner or the renter gets the passes;

- ➤ If an owner registers for passes, the passes will be mailed to the address the owner gives, either their mailing address or the Magnolia Ridge mailing address;
- > If the tenant registers for passes, they will be mailed to the Magnolia Ridge address;
- ➤ If a different tenant registers for passes for the same home, the tenant is to be notified that passes were previously issued and replacement passes can be purchased for \$5 each which is to be paid by either the tenant or the owner prior to the issuance of the pool passes.

We meet the second Thursday of every month. Residents are strongly encouraged to attend. These meetings are a great place to get up to date on the happenings in the neighborhood and a forum to express any concerns, questions, or compliments.
